## Terms and Conditions of Agreement and Membership

- A. This Designated User Agreement shall entitle Candidate, Owner to be considered for membership in the Club. This Designated User Agreement will not be acted upon unless (i) it is fully completed and executed, and the lifetime membership fee per pet of two hundred (\$200.00) dollars has been paid in full and (b) all other required information is provided. YOUR FOURTH PET WILL RECEIVE A FREE MEMBERSHIP.
- B. Candidate, Owner and Owner's spouse acknowledge that Member's Membership as a Designated User is not an investment in the facilities, nor does either provide an equity or ownership interest in the facilities and programs of the Club (the "Club Facilities"), and each is for recreational use of the Club Facilities only.
- C. Candidate, Owner and Owner's spouse acknowledge that a User only acquires a revocable license to use the Club Facilities in accordance with the Membership Plan and all documents referenced therein (the "Membership Documents"). The Club reserves the right, at any time and from time to time, in its sole and absolute discretion, to reserve memberships, to discontinue operation of any or all of the Club Facilities, to sell or otherwise dispose of the Club Facilities in any manner whatsoever and to any person whomsoever, to terminate any or all types of membership, and to make any other changes in the terms and conditions of membership or use of the Club Facilities.
- D. Candidate, Owner and Owner's spouse covenant and agree to indemnify and hold harmless the Club and Nemaocolin Wooflands, Inc. and Woodlands Animal Care Center, Inc. and its shareholders, directors, officers, employees, representatives, affiliates and agents in accordance with the terms of any and all agreements executed for services and included as provisions of the Membership Documents.
- E. Candidate, Owner and Owner's Spouse acknowledges that use of the Club Facilities may be restricted from time to time based on events, construction, renovation, maintenance and other causes.
